Chairman's Report

We held our first executive meeting on November 30th and discussed many items. The main topics were where we would hold future meetings and what the financial forecast looked like with the cost of room rentals in place.

Due to the ABC Restaurant implementing a \$50.00 per hour charge for our future meetings, it was decided to find an alternate meeting place with lower cost. As we had already used the Lantzville Legion for our Christmas Banquet, it was considered that this venue would be ideal and very suitable for our meetings. The room is larger, quieter, easier to arrange seating, and only \$15.00 per hour, therefore it was agreed to use this venue for our meetings. Unfortunately, the Legion already had commitments for Tuesday evenings and it was further agreed that we would change our meetings to the 3rd Thursday of each month. The first meeting will therefore be held on Thursday, January 20th.

We also discussed the format of our meetings based on feedback from our members' answers to Candy's questionnaire, and came up with a start time of 7:00 p.m., with the first section following a similar format to previous meetings, with the exception of reading out previous meeting minutes. After this section there would be a 10 - 15 minute break and the meeting will resume with a presentation, either technical, or of special interest in nature. It is expected that the meetings should end by 9:00 p.m. Minutes of monthly meetings will be posted on the website for review.

The financial forecast was reviewed and, with the extra cost for room rentals in place, it showed that a loss was expected for 2011. It was also pointed out that the cost of printing and mailing out hard copies of the BEANO to approximately 30 members was costing the Branch a considerable amount. It was therefore decided that the **annual dues should increase for 2011 to \$25.00 per member and \$30.00 for dual members.** Furthermore, as the BEANO is available to be printed by members on their own copiers, the Branch would start to charge for mailed out copies. **The future cost to anyone wanting colour copies of the BEANO mailed to them will be \$24.00 per year.** There will be no charge for the BEANO which is posted on the website.

One other topic raised by individual members to the executive was a request for our Branch to create an annual Restoration Award, which would be awarded to the best restoration project for the year, decided by members' votes. I would like to get feedback from members on this idea.

With the new executive in place, I am really looking forward to some positive changes in our Branch and having a great line up of fun and interesting events for 2011.

I would like to remind everyone that we will be having a meal at the ABC Restaurant on Tuesday, December 21st at 6:00 p.m. in lieu of our regular monthly meeting. Also, Janet and I have arranged for a 2nd Annual Polar Bear Walk on Sunday, January 2nd around Neck Point, followed by lunch at Piper's Pub.

I hope to see as many of you as possible for these two events, and for those that cannot make them, I would like to wish them all a merry Christmas and a very happy, fun-filled, New Year.

The Beano Belles finally retired, but went out with a bang. They hosted a quiz which showed the gentlemen in the club that the ladies know as much about cars as they do...even though the game was rigged!! In the end the men were each presented with a “thanks for participating” certificate.

Irene Thompson was presented with an award of appreciation for the many years of planning and working with the Beano Belles, as well as regaling us with her many verses of the OECC song.



SMITHS INSTRUMENTS

At one time, Smiths car instruments were as English as Dunlop tyres, string back gloves and, um, Lucas electrics. Most British cars from the 1920's to 1980's used Smiths instruments, or British Jaeger or VDO made by Smiths.

From beginnings as S Smith & Son, a jeweler making clocks and watches near the Elephant and Castle in SE London in 1851, Smiths industries became the dominant force between wars and after WW2 in auto, marine, industrial and aircraft instruments, car radios and heaters, anti-freeze and spark plugs.

Now, Smiths is a shadow of its former self, and although the management is highly regarded, is reduced to making scanners for airport security. It's growth, dominance and fading away mirrors in many ways that of the British watch making and motor car industries.

They acquired KLG spark plugs in 1929, and later merged it with Lodge, to compete with imported American Champion plugs. Core income from spark plugs funded growth and acquisition throughout the 1930's and 40's.

Smiths began to make electrical clocks and instruments in the early 1930's, moving to Cricklewood in North London on the Edgware Road then, just at the intersection with the new orbital North Circular Road, and reached a non-compete agreement with arch-rival Joseph Lucas. A substantial clock making business was established between 1930 and 1939, and they began to make aircraft instruments and automatic pilots. Instrument and automatic landing was added with the purchase in the 1950's of S.G. Brown, who my father was with, and the Sperry Gyroscope Company, becoming the aviation division. Marine instruments were added with the prewar purchase of Kelvin Hughes, who my uncle was with.

They acquired British Jaeger from the French-Swiss parent company in 1937, with the distribution rights in the Dominions, Protectorates and Colonies, and in 1931 production and distribution rights for Bosch and VDO equipment.

Fresh air car heaters, a real novelty, as against the older recirculatory type, were introduced, and car radios, under the Radiomobile brand. Later, Motorola radios were made under license.

Smiths chairman at that time was Ralph Gordon Smith, a keen horseracing man, and accordingly factories were built strategically near racetracks in Basingstoke and Cheltenham.

The recent trend has been to use warning lights in place of calibrated gauges.

Most car instruments are now made in a single dashboard unit for mass produced cars, and eventually Smiths had only one customer for instruments, for electrical fuel and oil pressure gauges. Ammeters were brought in from (gulp) Lucas.

Smiths stopped making clocks and watches in the 1970's, most car instruments, and car radios under the Radiomobile brand. They had been making Motorola radios also under license, and Bluecol car antifreeze.

The Radiomobile factory was nearby in what had been the prewar Bentley car factory on the North Circular Road.

It was close by the Van Den Plas coachworks, which built many vintage Bentley bodies, and which was later bought by BMC, eventually becoming a badge name for deluxe Austin and Jaguar saloon cars.

W. O. Bentley's original office had his original desk and office furniture (still there, maintained by the Bentley Driver's Club).

The Aviation Division became the main growth area of the company, was renamed the Aerospace Division in the 1960's and moved to Wembley, with the factory in Cheltenham.

Portland Plastics was acquired then, and the Medical Division became the second key division.

The Aerospace Division was sold to American GE in 2007, leaving Medical & Diagnostics the only remaining active areas in what was S. Smith & Sons, renamed Smiths Industries in the 60's, then Smiths Group, now Smiths. Their main area of business now is making security and x-ray systems for airports.

The incoming Executive met on Tuesday, November 30, 2010 at 7 p.m. in the home of Doug & Judy Unia to resolve outstanding and new issues.

Select a suitable new meeting venue: ABC has advised that they will charge \$50 per hour for meeting space. The Lantzville Legion will charge \$15 per hour, however Tuesday evenings are not available but it is believed we can rent the space the third Thursday of the month.

ACTION: Candy will determine the availability and advise the membership.

How often does the Executive need to meet? It was decided to meet on an as need basis and/or half hour prior to regular meetings, by conference call, email etc

Financials: The operating forecast for 2011 that Bill prepared was reviewed. It is evident that an increase in annual dues will need to be implemented in order to cover additional costs for meeting space. 7 pm to approximately 7:45 pm: - Regular meeting without the reading of previous minutes (these will be emailed along with the Agenda one week prior to the meeting)

The Mystery Car and Report on English Car World will alternate each month.

8:00 pm to 9:00 pm - Technical presentation and/or social hour.

The Presentations Coordinator will arrange and organize interesting technical presentations whenever possible, using the existing member's knowledge and skills, alternatively, find suitable speakers/topics/tours from external sources.
